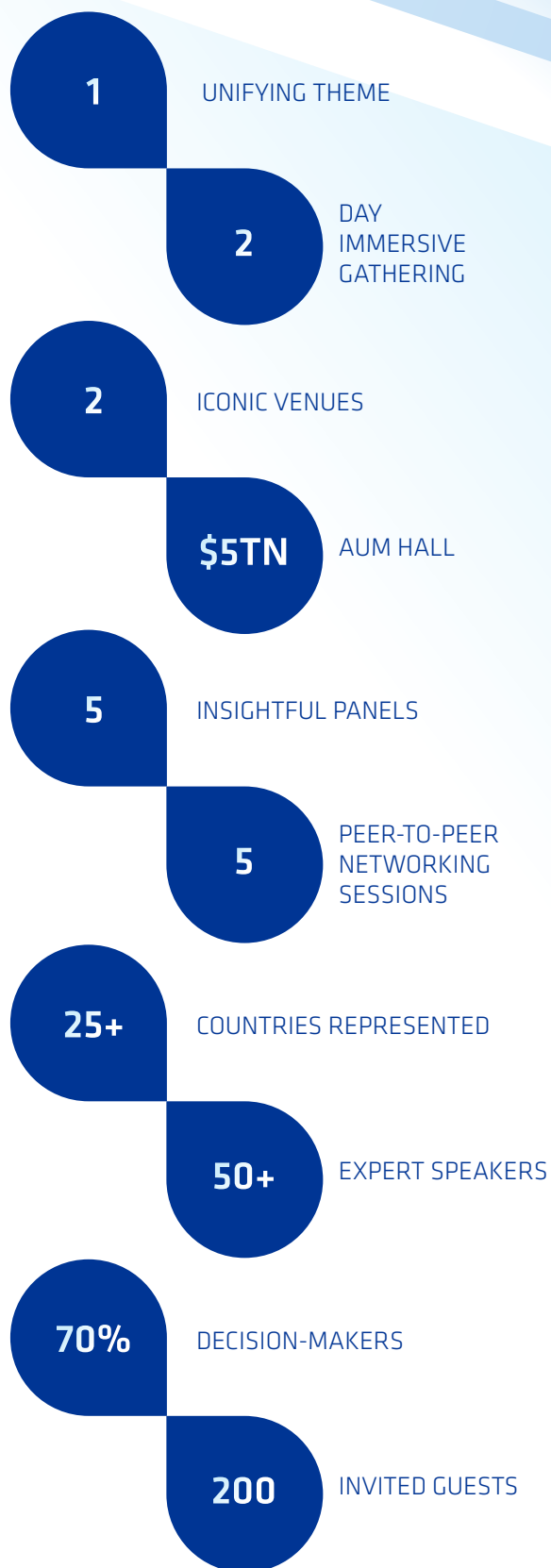

INVESTMENT 3.0: VIRTUAL ASSETS AND THE NEW DIGITAL WORLD ORDER

Sovereign wealth funds and institutional investors are increasingly engaging with digital assets and tokenization as part of their diversification strategies. Many are investing in blockchain infrastructure, tokenized real assets, and digital payment platforms to enhance liquidity, efficiency, and access to alternative asset classes. Some are allocating capital to crypto funds, fintech ventures, and tokenized securities, while others explore CBDCs and stablecoins within evolving regulatory frameworks. As tokenization gains traction across real estate, private equity, and fixed income, institutional participation in digital assets is set to reshape traditional investment strategies.
