### **Ruston Smith**Non-Executive Chair – Tesco Pension Fund

Ruston has 40 years of experience in the pension fund and investment industry.

He was the former Group Pensions, Insurable Risk and a People Director at Tesco and CEO of Tesco Pension Investment Ltd - FCA approved in house investment manager. Ruston is now the Chair of the Tesco Pension Fund (DB and DC) and FCA approved Tesco Pension Investment Ltd, Independent and Chair of the Funding and Investment Committee for the BAE Pension Fund, Non Exec Chair of JP Morgan Asset Management Ltd (UK and EMEA), Non Exec Chair of Smart Pension Ltd, Non Exec Chair of the Asset Management Exchange ICAV, Non Exec Chair of Guiide, Non Exec Chair of the Pensions Management Institute and Chair of GroceryAid, an industry charity.

Ruston was on the DC Patient Capital Steering Committee and the Bank of England, Treasury and FCA's Steering Group on Investment in Productive Finance and now sits on the Expert Panel for the British Venture Capital Association. He was a former Chair of the PLSA, Co Chair of the DWP's 2017 Auto Enrolment Review Board, led the Simpler Annual Statement initiative (now a regulatory requirement), chaired the cross regulator and industry 'Standardised Assumptions Group', led the Members' Costs and Charges Initiative and co-leads the Lifetime Savings Initiative. MBA with distinction and a Fellow of the Pensions Management Institute, the Chartered Management Institute and the Royal Society of Arts.









## **David Pitt-Watson**Entrepreneur and writer

David Pitt-Watson, born and raised in Scotland, has been appointed Chair of the new Scottish Taskforce for Green and Sustainable Financial Services, while also serving as a Fellow (Finance) at Cambridge Judge Business School. This taskforce, initiated by the Scottish Government with backing from Scottish Financial Enterprise, brings together approximately thirty leading financial institutions with the aim of coordinating and enhancing Scotland's sustainable finance cluster to establish it as a global center of excellence in green finance. Notable figures like Mark Carney, UN Envoy for Climate and Finance and former Governor of the Bank of England, Kate Forbes, the Scottish Cabinet Secretary for Finance, and John Glen, the UK Economic Secretary for the Treasury, were present at the taskforce's recent public launch event.

David's deep involvement in sustainable finance spans many years. He co-designed a course at Cambridge Judge Business School titled "Purpose of Finance," which was awarded the grand prize in the 13th annual Page Prize for Sustainability Issues in Business by the Darla Moore School of Business at the University of South Carolina. This course, tailored for the Master of Finance (MFin) program at Cambridge Judge, reflects his commitment to advancing sustainability in financial education.

Educated at local schools in Bearsden and Aberdeen, David pursued higher education at Queen's College, Oxford, before earning a scholarship from the North of Scotland Rotary Club to pursue an MBA at Stanford University. Married to Ursula Barnes, he is the proud parent of three grown-up children.







# **Lord Dominic Johnson**Minister for Investment, Department for Business and Trade

Lord Dominic Johnson of Lainston CBE was appointed Minister of State in the Department for Business and Trade on 7 February 2023.

He was previously Minister of State (Minister for Investment) in the Department for International Trade between 24 November 2022 and 7 February 2023.

He was Minister of State jointly in the Department for International Trade and the Cabinet Office between 2 October 2022 and 28 October 2022.

He has spent over 25 years in financial services, beginning his career at Robert Fleming in 1995, before moving to Hong Kong to work for Jardine Fleming and then in 2002, after a series of dot com start ups, heading the marketing for Lloyd George Asset Management - an emerging markets specialist firm.

In 2007 he co-founded Somerset Capital Management LLP as an employee-owned democratic partnership, focussing on pension fund management in developing countries.

Between 9 November 2020 and 2 October 2022 Dominic was a non-executive board member of the Department for International Trade. He was Chair of the department's Audit and Risk Assurance Committee.

Between 2017 and 2019 he was vice-chairman of the Conservative Party.







# **H.E. Dr Nayef Falah Al-Hajraf**Secretary General of the Gulf Cooperation Council (2020-23)

H.E. Dr Nayef Falah Al-Hajraf was appointed secretary general of the Gulf Cooperation Council on February 1, 2020. He previously served as Kuwait's 19th minister of finance. Al-Hajraf has more than 15 years of experience in public and private sector management, education, and financial consulting. Prior to his appointment, Al-Hajraf served as the country's chief regulator of marketable securities in his capacity as the chairman of the Board of Commissioners and managing director of the Kuwait Capital Markets Authority from 2014 to 2017.

During his tenure, the Capital Markets Authority matured into a world-class regulator and oversaw the privatization and development of Boursa Kuwait Securities Company, the operator of the country's only stock exchange. Al-Hajraf previously served as Kuwait's minister of finance for a brief period in 2012 and minister of education and minister of higher education from 2012 to 2014. He was also a member of the First Board of Commissioners of the Capital Markets Authority in 2010 and a member of the Supreme Petroleum Council. He holds a PhD in accounting and finance from the University of Hull, United Kingdom.







## **Dr. Jen Jones**CEO Galapagos Conservation Trust

Dr. Jen Jones serves as the CEO of the Galapagos Conservation Trust (GCT), where she leads efforts to preserve and protect one of the world's most unique and biodiverse ecosystems. With a background in conservation science and management, Dr. Jones brings a wealth of expertise to her role in safeguarding the Galapagos Islands' fragile ecosystems and endemic species.

Dr. Jones's passion for conservation and environmental stewardship has been evident throughout her career. She holds a Ph.D. in Conservation Biology and has dedicated her research to understanding the ecological dynamics of island ecosystems, with a particular focus on the Galapagos archipelago. 


